RESOLUTION #2023-6A (Replaces #2023-6) INMATE ROOM & BOARD FEES

WHEREAS, the Poweshiek County Sheriff has determined that Resolution #2018-14 dated December 11, 2017, is outdated regarding the collection of fees for room and board at the Poweshiek County Jail, and

WHEREAS it would be in the best public interest for the Poweshiek County Sheriff's Office to charge a specified rate set down,

NOW THEREFORE BE IT HERBY RESOLVED by the Poweshiek County Board of Supervisors that the Poweshiek County Sheriff's Office is hereby authorized to collect fees for room and board from every sentenced inmate in the custody of the Poweshiek County Jail as follows:

- 1. Poweshiek County sentenced inmate in the custody of the Poweshiek County Jail shall pay forty-five (\$45.00) dollars per day. Any part of a 24-hour period is considered a day. Out of county inmate holds shall pay forty-five (\$45.00) dollars per day.
- 2. Poweshiek County sentenced inmate whom the courts have allowed to serve their sentence, as a work release status, will pay the Poweshiek County Sheriff's Office fifty (\$50.00) dollars per day. If sentenced out of county, inmate will pay seventy (\$70.00) dollars per day if wanting to serve in the Poweshiek County Jail.
- 3. Inmates housed in Poweshiek County Jail from another agency shall pay fifty-five (\$55.00) dollars per day.
- 4. Any part of a 24-hour period is considered a day.

Board accepted resignation notice of Lauren Hosch-Lorenzen, Recorder Clerk effective immediately.

9:00 a.m. John Clayton, Rose Hendrickson, Joel Nielsen, and Randy Read met with board to discuss the possibility of paving 350th Avenue from V16 (150th) to 140th Street. Clayton stated in the past this stretch of road had been on the county 5-year plan but was then taken off the plan. He is asking the board to place this road back on the 5-year plan. Clayton presented the board with a petition signed by 91 individuals in favor of paving this road. Clayton feels that chip and seal would be the cheapest option. Clayton stated he feels if this was paved, it would draw more people to develop the area, help build up community in the area and economic development. Madison Church does a lot for the community.

Randy Read stated he is with Madison Church and feels paving the road would benefit the church and congregation members have expressed their concern with driving on gravel. Read stated it wasn't an end all and the church would continue but he would be very thankful for a paved road.

Joel Nielsen with Madison Church stated he would like to see this road paved. He stated the church has been there for 142 years and a lot of residents from Madison Township and northern Poweshiek County attend church there. They average 100 people in their congregation. Nielsen stated the church does a lot for the community and will continue to do so.

Rose Hendrickson stated a concern with the damage gravel does to vehicles.

Board stated they have final decision to make recommendation on road work. Dawley stated they will speak with the engineer to gather more information. Roudabush stated this road is on the radar but needs to get more information, such as traffic count, estimated costs and looking at county budget. Clayton would like to hear from board on their stance today. Doty stated the board is not in the position to make a final decision today and will gather more information.

Board placed call to Don Kriegel regarding the farm lease. Don Kriegel inquired about an extension to their farm lease agreement. Board stated that they have had inquiries from other individuals expressing interest in renting the farm ground. Board stated they will put the land for public auction bid on September 15, 2022, at 9:00 a.m.
